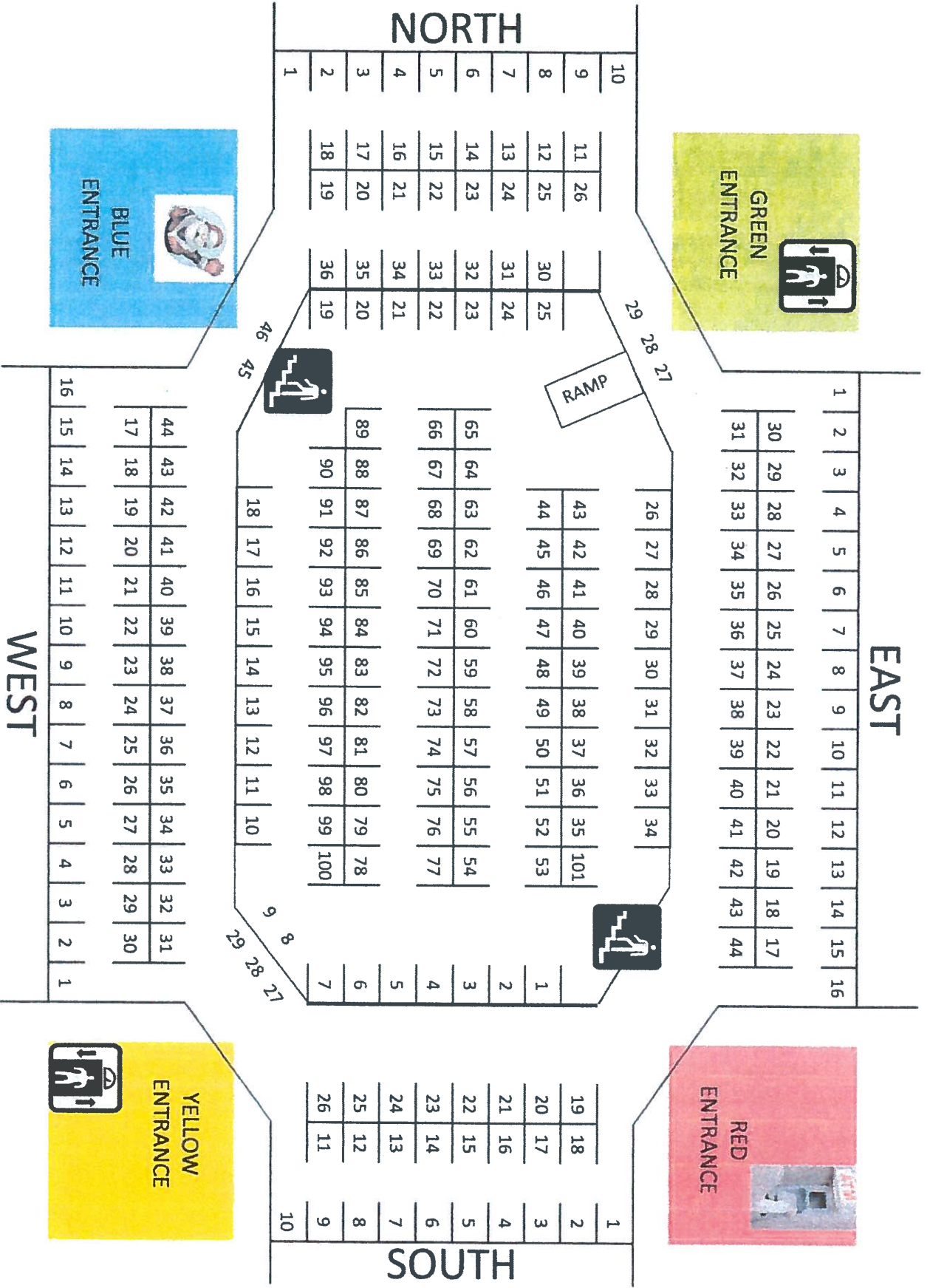
General Show Rules: 2020 *Lit'l Bita Christmas Arts & Crafts Show –34th Anniversary 1987-2020*

1. Application Renewal deadline with a **\$100 non refundable deposit per booth** for the **2020** show is **May 15, 2020**. Any booth space rented after that date will be assigned, as available. After acceptance into the show, any balance due must be paid by **July 31, 2020**. You are not guaranteed to receive the same booth spot for future shows, but efforts to fulfill booth requests to returning vendors will be attempted. **\$100 and higher per booth: Late Fees, cancellation fees, special request fees may be charged at the discretion of the coordinator. No refunds after October 15.**
2. The **2020** show dates are tentatively scheduled for **November 13, 14, 15, 2020**. 2020 Accepted Vendors will receive show information about two weeks prior to the show. Vendors should follow up with the coordinator on booth assignments if no correspondence has been received by October 31, 2020.
3. The Show Rules Committee will tour all booths to insure a quality show and that show rules are followed. Any item deemed unsuitable for the general public will be removed. Please understand that disregard of the published and attached show rules will be considered a breach of contract.
4. To be considered as an Arts & Crafts Vendor, **all merchandise displayed must be 75% or more handmade or customized** by the exhibiting artist or vendor. If the Show Rules Committee and the Show Chairperson determines your merchandise does not meet the criteria, you may be moved to the Commercial Division for future shows or not allowed to return.
5. For **new exhibitors** or new items for renewals, three photos and a one page written description of the craft must be received prior to **November 10, 2020 with a \$30 non-refundable application fee per booth requested**. No emailed applications and photos will be accepted. **New vendor requests are put on a waiting list until booths are available.**
6. Exhibitors may display and sell only that craft category or art medium for which they were approved and **may not transfer or share the exhibit space without prior consent**. Exhibitors are encouraged to demonstrate or work in their booth.
7. Set up starts on **Thursday, November 12, 2020** at 2PM unless the chosen venue schedules an event that evening, in which case set up will not begin until 7AM on **Friday, November 13, 2020**.
8. All display equipment is the sole responsibility of the exhibitor. The Lit'l Bita Christmas Show does NOT have moving equipment such as dollies, carts, or other equipment available for use. You must bring your own moving equipment.
9. Each display should be clean and neat and tables should be draped to the floor on all sides with a suitable covering. Extra stock and utensils must be stored out of sight during the entire length of the show. Place trash in the aisle at the end of each day so that maintenance may pick up your trash. Security will be present after hours. Fire code requires all electrical outlets be unplugged at the end of each day. Food vendors may be inspected by the Arkansas Dept. of Health.
10. The booth is to be open and staffed during the listed dates and times of the show. Booths vacated may not be renewed.
11. No exhibit may be set up so as to obstruct vision of or access to another exhibit or so as to impede traffic flow.
12. Chairs and tables will be provided at an additional cost. Requests **MUST** be made in advance.
13. Display materials must be contained in the 12' X 12' booth space. Electricity is provided, 110/20 amp outlets only.
14. **After initial unloading, exhibitors will park their vehicles at the outer perimeter of the parking lot** or other area so designated. RV parking maybe available for an additional fee.
15. Exhibitors cannot bring pets into the show and should not bring small children to the show.
16. Helium balloons are not allowed in the venue unless prior permission is given.
17. Eating, drinking, and the playing of radios, televisions, noise makers in the exhibit area is strongly discouraged.
18. No sale signs (ex: 50 %) or trademark signs (ex: Dixie Outfitters) can be hung or displayed outside the booth or in venue.
19. Selling handmade items bearing a trademarked logo or verbiage of Arkansas State University requires a license in the Crafters Program. For more information visit: <http://www.astaredwolves.com/craftersprogram>
